AGENDA ITEM: Resolution 09-24/25 Condemnation of Real Property

The administration requests and recommends the Board take final action to authorize condemnation of 15 (fifteen) properties and 1 (one) billboard lease (Resolution Exhibit A), which the administration seeks to assemble and acquire as the site for the Renton High School Replacement and Site Expansion. The administration believes that the acquisition of these properties and lease is necessary to effectively and

efficiently design and build a high school that best serves the School District needs for the life of the school, which are public uses of the properties for a public purpose. The administration believes the acquisition of these remaining pieces of the assemblage is necessary for the proposed public use and for the benefit of the public to allow us to build the best high school possible on the site and meet the scheduled opening date.

In order for the school district to take final action to proceed with acquisition by eminent domain (condemnation), the Board is required to hold a public hearing and take comments for and against the proposed condemnation, and should it find the condemnation appropriate, authorize the condemnation. The hearing is scheduled for February 27, 2025. A proposed Resolution No. 09-24/25 is attached, reviewed by our legal counsel for the Renton High School Replacement and Site Expansion.
